# Silicon Valley's biggest foe is getting tougher

With more authority from the EU, Margrethe Vestager envisions a more aggressive agenda

**MARGRETHE VESTAGER** SPENT the past five years developing a well-earned reputation as the world's top tech industry watchdog. From her perch overseeing Europe's competition rules, she fined Google more than \$9 billion for breaking antitrust laws, and forced Apple to pay about \$1.45 billion for dodging taxes.

Now she says work, which made her a hero among tech critics, did not go far enough. The biggest tech companies continue to test the limits of antitrust laws, behave unethically and push back against government intervention, she said. But she said the public's growing scepticism about technology has given her an opportunity for a tougher approach. "In the last five years," Vestager said in an extended interview, "some of the darker sides of digital technologies have become visible."

forms from liability for content posted by users. She is also working on policies to make companies pay more taxes in Europe and investigating how the companies use data to box out competitors.

Vestager has pledged to create the world's first regulations around artificial intelligence and called for giving collective bargaining rights to so-called gig economy workers like Uber drivers. The push comes on top of a probe into Amazon's use of data to gain an edge on competitors that had already started, and her look into accusations of unfair business practices by Facebook and Apple.

"She has these accomplishments, but she didn't get as much as she wanted," said David Balto, a former lawyer in the Justice Department's antitrust division whose clients now include large tech companies. —NYT
